### CONTINUING THE FIGHT FOR LOCAL CONTROL OVER CREEKS, STREAMS

Seeing the devastation caused by the California wildfires earlier this year took me back to last August when several communities in our area were ravaged by flooding.

After every natural disaster there must be a concerted effort to reevaluate the decisions leading up to the event. I firmly believe the people "on the ground" in our communities know what needs to be done to help at least minimize the damage caused by these disasters.

That's why I am reintroducing three bills designed to give local officials and landowners the tools they need to better maintain our creeks and streams and help prevent flooding.

House Bill 88 would address funding shortfalls by requiring certain royalty payments to the Commonwealth for oil and gas production to be used for creek and stream maintenance.

House Bills 327 and 328 would address permitting challenges by allowing local government organizations to apply for permits for continuing maintenance for a period of at least 10 years and requiring an expansion of the work area associated with emergency permits for stream clearing activities.

The content is geared to parents and grandparents of young kids and teens. It is not recommended that young children attend due to the nature of the issues being discussed.
