EXPANDING OPPORTUNITIES FOR ATV/UTV RIDERS

After lengthy conversations with PennDOT officials, I'm excited to report the agency has unveiled a new policy that could significantly increase riding opportunities for ATV/UTV enthusiasts!

Based on the success we've seen with the Regional Trail Connector pilot program that allowed the use of DCNR roads to better connect trails, PennDOT is adopting a policy that will better facilitate the opening of certain sections of state highways to also serve as connector roads between trailheads.

Requests must be initiated by your municipal officials, so if you have suggestions

for a section of roadway that could serve as a connector, talk with them about it!

This will improve the experience for local riders and serve as a draw to riders from outside the area. We've already seen results from the pilot program with the estimated economic impact in Tioga and Potter counties at \$8.2 million in 2022 and \$11.7 million in 2023. Further expanding opportunities will only build on these impacts. Get out and enjoy all our region has to offer!



ON THE ISSUES

While being in the minority party in the state House has made it more challenging to advance some of our legislative priorities, rest assured I'm fighting as hard as ever to make our voices heard on the issues that matter most. Here are just a few of the bills I am working on at the state Capitol.

Voter ID (House Bill 759): Requiring voters to show ID before casting a ballot is broadly supported as a means to improve election integrity. My bill would ensure identification requirements are easily met by providing a durable voter registration card to all eligible voters.

Lifeline Scholarships (House Bill 1489): No child should be trapped in a school that isn't meeting his or her needs. This bill would affect families who either have a household income below 350% of the federal poverty guidelines or who reside in the attendance areas of the state's lowest-performing schools.

Stream Maintenance (House Bills 88, 327 and 328): When floodwaters rise, lives

and livelihoods are at risk. These bills seek to improve the maintenance of our creeks and streams to prevent flooding by increasing available funding and streamlining permitting processes for stream clearing.

Responsible Energy Development (House Bill 347): Demand for energy is on the rise, as is the cost. My bill would allow for the extraction of oil and gas resources underneath our state lands in an environmentally conscious manner.

Support for Dairy Industry (House Bills 177 and 179): Dairy is a vital segment of our state's agriculture industry, providing jobs to those who work in the industry and nourishment to those of us who enjoy milk, yogurt, cheese and more. These bills provide a tax incentive for dairy processing facilities and empower our schools to purchase and serve whole milk and 2% milk to students.
